

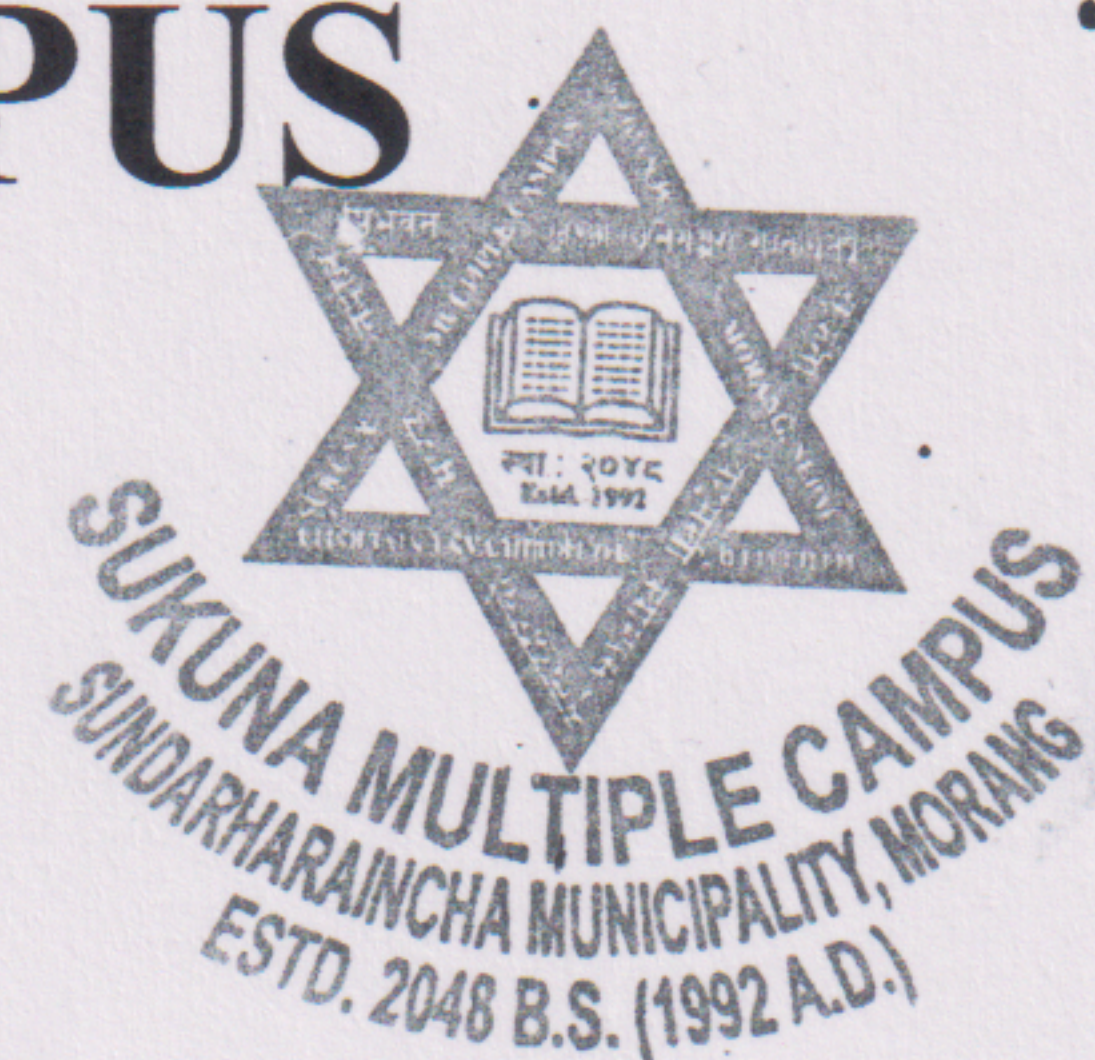



The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs on 2079 Aswin 03 BS at the office of SUKUNA MULTIPLE CAMPUS, SUNDARHARAINCHA MUNICIPALITY, WARD NO. 12, MORANG, NEPAL.. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security in amounting to a minimum of **Nrs. 3,40,000.00** which shall be valid for 30 days beyond the validity period of the bid (i.e., **2079 Magh 05 BS**)
